- Some people say that it should be removed from India as well. However, the **government of India is not ready to abolish capital punishment.**



# Should capital punishment be abolished? No

- Capital punishment **brings fear into the minds of criminals**. The purpose of capital punishment is to give a strong message to society. So, it **works as a deterrent.**
- A person who has committed heinous crimes does not deserve to be part of society again. If allowed by society, he may commit the crime again.
- Some people say they should be put in jail for their whole lives. But **there are provisions for parole**.
- Criminals who take parole come out of jail, and society will be in danger. Parole is awarded in cases of emergency at the criminal's house, like death or marriage.
- In India, the death penalty is given only in the **rarest of rare cases**, meaning in exceptional cases. So, by awarding the death penalty for a heinous crime, the **judiciary sends a message to society** about the severity of the case.
- Before being hanged, a criminal gets various opportunities to prove his innocence.
- The process in the Indian courts is as follows: Trial court > High Court > Supreme Court > Review petition in the Supreme Court > Presidential mercy petition > Execution of a criminal.
- If one court gives the wrong judgement, it will be corrected by another court. If all of them are firm in their views, he must be awarded capital punishment.
- We can say that capital punishment somehow protects value and morale in society.
- If, with the background of the criminal, it is **evident that he cannot be transformed**, it is better to take his life rather than give pain to another victim in society.
